I, the undersigned natural person of the age of eighteen years or more acting as incorporator of a corporation existing under the PROFESSIONAL CORPORATION ACT (D.C. Code, 2001 edition, Title 29, Chapter 4), adopt the following Articles of Incorporation:

FIRST: The name of the corporation is Owasco, P.C.

SECOND: The period of duration is perpetual.

THIRD: The purpose for which the corporation is organized is to provide legal, lobbying and consulting services.

FOURTH: The aggregate number of shares, which the corporation is authorized to issue, is one.

FIFTH: There are no preferences, qualifications, limitations, restrictions and special or relative rights in respect to the shares of each class.

SIXTH: The corporation will not commence business until at least one thousand dollars (\$1,000) has been received as initial capitalization.

SEVENTH: There are no provisions limiting or denying to shareholders the preemptive right to acquire additional shares of the corporation.

EIGHTH: There are no provisions for the regulation of the internal affairs of the corporation.

NINTH: The corporation will be located at 818 Connecticut Ave., NW Washington, DC 20006. The registered agent is Eric D. Schwerin and is located at the same address.

TENTH: There is one director constituting the initial board of directors for the corporation. The following director will serve as the director until the first annual meeting of shareholders or until their successors are elected and shall qualify:
